



## INFORMATION FOR DOCTORAL STUDENTS IN HUMAN MEDICINE, DENTISTRY AND HUMAN BIOLOGY FOR THE PUBLICATION SERVICES THESES VIA THE "UNIVERSITÄTSBIBLIOTHEK PUBLIKATIONSDIENSTE DISSERTATIONEN" (UNIVERSITY LIBRARY PUBLICATION SERVICES FOR DISSERTATIONS)

After the oral examination each dissertation must be published **within one year**. The obligation to publish can be fulfilled by **uploading 1 electronic version** to the publication server "Electronic Theses of LMU Munich" and **submitting 2 printed copies** (= a total of 3 mandatory copies) and 2 forms „Submission form for electronic theses“.

The following steps are necessary for publication via the university library:

### **Before printing:**

1. Make sure you have the names of your supervisor and your second TAC-member, as well as the date of your defense on the second page of your dissertation.
2. Upload the electronic version of your dissertation to the publication server "**Electronic Theses**" (<https://edoc.ub.uni-muenchen.de/help/>). Read the instructions before uploading (blue button on the right). **Do not sign the affidavit in the electronic version** of your dissertation, but enter your name in the signature field. Do not forget the place and date.
3. The 2 printed copies **must be bound with a permanent/glued binding**. A soft cover is sufficient. Foil covers become brittle over time and should therefore not be used.
4. The book or soft cover must be labeled with the title of the dissertation, the year of the oral examination and the name of the doctoral candidate. It is easiest to print the title page of the dissertation also on the cover.
5. The curriculum vitae no longer has to be included. Instead of your home address you can enter your work address on the remaining forms.

### **After printing:**

6. The affidavit must be signed by hand in the two printed copies. In the electronic version please type your name in the signature field. Don't forget the place and date!
7. The doctoral supervisor signs one of the two printed copies next to his/her name on page 2.

### **Submission to "Publication Services Theses":**

8. Hand in two printed copies of your dissertation together with the "Submission form for electronic theses" (Download: <https://edoc.ub.uni-muenchen.de/help/> paragraph 5) in duplicate during the opening hours of the "Publication Services Theses" (address: Leopoldstraße 13, room 1108). Please fill out the form on the computer, print it out twice and hand them in with your original signature.
9. Your printed documents can also be submitted by a third party (a mandate is not necessary) or sent by post (address: Publikationsdienste Dissertationen, Leopoldstraße 13, 80802 Munich).
10. The obligation to make the dissertation accessible to the scientific community in an appropriate manner is also fulfilled, when the publication is delayed due to a blocking note ("Sperrvermerk") based on
  - a patent registration process or
  - a publication in a magazine.For the blocking note you have to upload your thesis electronically and hand in the 2 printed copies of the dissertation, 2 copies of the form "Submission form for electronic theses" and 2 copies of the relevant blocking note form (Download: [https://www.ub.uni-muenchen.de/schreiben/dissertationen\\_habilitationen/index.html](https://www.ub.uni-muenchen.de/schreiben/dissertationen_habilitationen/index.html) or instructions, paragraph 9 or 10). Please submit all forms with original signatures.

The **doctoral certificate** is only issued after the successful submission of all documents and can be received four weeks following the submission at the earliest. It is only allowed to hold the doctorate after receiving the doctoral certificate.

Alternatively, the entire dissertation can also be published in a journal, series of publications or as a book. You can find information on this in the doctoral regulations.
